### SAS Group's August traffic figures

- SAS Group's traffic decreased by 17.1% during August and seat capacity was down 20.5% vs. 2008.
- SAS Group carried 2.0 million passengers in August, down 15.7% vs. 2008.
- Total passenger load factor in August was 76.1%, up 3.1 p.u. vs. August 2008.

#### Group market trends and yield development

The yield for Scandinavian Airlines in July was down by 3.2% as expected. For August 2009, the change in yield is expected to be more negative indicating further yield pressure going forward. The summer leisure traffic developed well and combined with capacity reductions helped to improve load factor by 3.1 p.u. in August. The yield pressure in combination with the weak demand adds further challenges to the industry and requires actions in order to mitigate the negative revenue impact. Negotiations with unions with the objective to reduce costs have been initiated. The market continues to be unpredictable and the uncertainty regarding the timing of the recovery is considerable.

The SAS Group is currently implementing a new strategic approach – Core SAS - to secure a future profitable SAS. The strategy includes cost initiatives of SEK 4.5 bn as well as a 20% reduction in capacity. The implementation is well on track. An additional SEK 2.0 bn cost savings was initiated in August 2009.

## **SAS Scandinavian Airlines**

- Total number of passengers was 1.8 million during August, down by 16.9%.
- The traffic decreased by 18.1% and the capacity was down by 21.9%.
- The August load factor increased by 3.5 p.u. to 77.1%.

The intercontinental traffic decreased 19.0%, but the capacity was down by 21.3% as a second intercontinental aircraft was grounded. This resulted in an improved load factor of 2.6 p.u. that reached 89.3%. Traffic on European routes decreased by 19.5%, but the load factor improved by a strong 5.3 p.u. The European capacity was above all reduced from Norway due to closure of unprofitable leisure routes. The

intrascandinavian traffic decreased 16.0 % and the capacity was reduced by 24.3% resulting in a strong improvement in the load factor. The Swedish and Norwegian domestic traffic decreased by 12.2% and 12.4% respectively, with improved load factors.

### Widerøe's traffic development

Widerøe carried 166.000 passengers in August, down 1.4% vs last year. The lower volume was a result of a 7.5% capacity reduction. The overall load factor increased by 3,6 p.u. to 62.1%. The reduced capacity has been implemented primarily on Widerøe 's international routes. On domestic routes, the capacity was increased by 4.3% in combination with an improved load factor of 2.7 p.u.

### Blue 1's traffic development

Total passenger volumes were 14.1% lower than last year but the traffic only decreased 3.0% as the capacity was reduced by 0.5%. The capacity was increased on European routes due to three new destinations. The total load factor decreased by 1.8 p.u. to 69.5%. On domestic routes, capacity and traffic was lower than last year as one destination was closed and smaller aircraft were used.
