ArosMaizels AB i Sverige har ændret navn til Nordea Securities AB, og de finske selskaber ArosMaizels Corporate Finance OY og ArosMaizels OYj har antaget navnene Nordea Securities Corporate Finance OY og Nordea Securities OYj.

ArosMaizels-varemærket vil blive brugt, indtil ændringsprocessen er gennemført, og de juridiske navne er blevet registreret. Nordea Securities-varemærket forventes at blive lanceret den 7. maj i år.
