Strategic order from Danish county

Sectra to digitize radiology at hospitals in Ribe county, Denmark

Sectra, the Swedish IT and medical technology company, has signed a contract with Ribe County Council in Denmark for a complete integrated radiology IT-solution.

The order is for Sectra's system for processing and archiving of digital images (PACS) and Sectra's radiology information system (RIS), which will be used at the four radiology departments of Ribe County. The entire County performs in total approximately 135,000 radiology examinations annually. The system will handle the entire workflow from request to report, including integration with referring clinics. The county radiology departments are scheduled to be in full digital operation by the beginning of 2004.

"We chose Sectra based on our goal to have the entire Ribe County work as one virtual radiology department, both paper and film free," says Bent Poulsen at the Social Healthcare Committee at Ribe Amt. "Sectra's digital radiology solution fulfils our high demands on quality and user-friendliness and can be integrated with the other IT-systems at the hospital", Bent Poulsen adds.

With Sectra's system radiology departments throughout Ribe County will be able to work completely without paper and films.
