

Connex Romania order capacity upgrade for Mobile VPN

* By using Mobile VPN (Virtual Private Network) voice calls and other communication, such as SMS and similar services, can be managed as if they were carried over private networks and exchanges, despite the fact that the traffic is routed through a public network, e.g. the Romanian GSM network. Operators offer this service to companies and organisations that can increase their availability and to manage and make their telecommunications more efficient through features such as differentiated call rates, short numbers and allocation of different levels of authorisation.
