**As of today, international Powerwave Technologies, Inc. is listed on Stockholmsbörsen's O list.**

Powerwave, primary market listed on NASDAQ, is a global telecommunication company. The company supplies wireless solutions in Antenna Systems, Base Station Systems and Coverage Systems, for wireless communications networks in over 50 countries in four continents. In 2003, Powerwave reported revenues of USD 239 million.

Powerwave Technologies acquired the Swedish company LGP Allgon in May, 2004. LGP Allgon was listed on Stockholmsbörsen until June 1, 2004.
