Sifo Group sells telephone center in Borlänge

Sifo Group's Sifo Research & Consulting Division and Hermelin Research have reached an agreement whereby Hermelin Research will take over Sifo Research & Consulting's telephone interview center in Borlänge (in accordance with the press release dated July 1, 1999).

"The long-term cooperation agreement with Sifo Research & Consulting means a great deal to us," says Carl Peter Bernström, President of Hermelin Research. "In addition, the contract gives Hermelin Research the Nordic region's largest capacity for data collection through telephone interviews."
