The dialysis center provides outpatient hemodialysis and home treatment services to over 180 patients. Dialysis treatment and related patient services will continue to be under the supervision of the medical directors affiliated with Saint Francis. As part of this transaction, Gambro Healthcare has also contracted to provide acute dialysis services to Saint Francis.

With this acquisition, Gambro now serves over 1,175 patients in the state of Connecticut and maintains its position as the leading provider of renal care services in that state. "Saint Francis Hospital and Medical Center was selected because of Gambro's strategic plan to develop dialysis services throughout the state of Connecticut and the New England market. Saint Francis has a long history of providing quality care to patients with end stage renal disease in the Hartford, Connecticut area and a strong reputation as the largest Catholic hospital in the New England region," stated Mats Wahlström, President of Gambro Healthcare. "This acquisition is another step towards our goal of becoming the world's leading provider of high-quality renal care services."
