## **Axfood's sales September 2005**

Net sales\* (excluding VAT) for stores in Sweden owned by the Group, increased by 8.9 % for the month of September, of which same-stores decreased by 0,3 %. Consolidated net sales totalled SEK 2,746 m (2,741), an increase by 0.2 % compared with the same period a year ago.

Under the period January-September 2005 the increase was 4.0 % for stores in Sweden owned by the Group, of which same-stores decreased by 3.0 %. Consolidated net sales totalled SEK 24,475 m (25,330), a decrease of 3.4 %. Of total sales, the Swedish operations accounted for SEK 20,781 m (21,425) and Spar Finland for SEK 3,694 m (3,905).

**Hemköp's** sales increased by 4.3 % during the month, of which same-stores decreased by 1.1 %. Accumulated sales increased by 0.7 %, of which same-stores decreased by 5.2 %.

**Willys** sales increased by 11.5 % during the month, of which same-stores increased by 1.1 %. Accumulated sales increased by 6.1 %, of which same-stores decreased by 1.5 %.

**Willys hemma** increased its sales by 1.0 % during the month, of which same-stores decreased by 9.3 %. Accumulated sales decreased by 3.8 %, of which same-stores decreased by 10.7 %.

**Spar Finland's** sales decreased by 1.9 % or by 4.8 % in local currency during the month. Accumulated sales decreased by 5.4 %, in local currency the sales decreased by 6.0 % compared with the same period a year ago. For stores owned by the Group the increase in local currency was 1.0 %, of which same-stores decreased by 5.4 %. For stores owned by the Group accumulated sales in local currency decreased by 0.6 % of which same-stores decreased by 7.5 %.
