



## Ericsson, Volvo and Telia form joint company – WirelessCar – to deliver mobile e-services to the automotive industry

Ericsson, Volvo and Telia announce the formation of WirelessCar Corporation at the Geneva Motor Show. The joint company is the first of its kind and will develop and market complete solutions for mobile eservices to vehicle manufacturers and fleet operators.

WirelessCar will enable the global automotive industry to implement, and to benefit from, mobile e-services. The company will offer solutions that connect vehicles to a wide variety of mobile e-services; such as roadside and emergency assistance, access to Internet services, vehicle software management and remote diagnostics.

"This joint initiative will bring to life the exciting new market for mobile eservices in vehicles. WirelessCar is a natural extension of our vision of anywhere, anytime communication. By bringing together the strengths of Volvo, Telia and Ericsson, WirelessCar is able to join competencies from the different industries and act as a unique one-stop provider in this new emerging area," says Jöran Hoff, Vice President and General Manager, New and Special Business Operations, Ericsson.

"For Telia this is a formidable way to provide the whole portfolio of intelligent operator solutions for private and fleet customers. We are happy to have such partners, who understand the high standards of the vehicle industry and mobile communications. WirelessCar will be providing state-of-the-art mobile solutions to its customers," says Östen Mäkitalo, Chief Technology Officer, Telia Mobile.

So far advanced mobile e-services have been mere visions, WirelessCar will make them come true," says Jan Hellåker, President of WirelessCar.



Initially the owners hold three equal parts of WirelessCar, but additional owners will be invited over time.

The new company will be headquartered in Gothenburg, Sweden.

The formation of this company is subject to EC regulatory approval.
