FAGERHULT HAS INITIATED TRADE UNION NEGOTIATIONS WITH INTENTION TO CLOSE THE PRODUCTION UNIT IN ÖRNSKÖLDSVIK

The Swedish lighting company Fagerhult, listed on the Stockholm stock exchange, today announced that negotiations have been initiated with the trade union representatives, with the intention to close the production unit in Örnsköldsvik. A final decision regarding closing down the unit is expected at the next board meeting on 13 December, when the negotiations are presumed to be concluded.

The unit today employs 128 people, of who 105 work with the production of Fagerhult's lighting fittings. The main part of the production will be moved to the company's other units in Sweden, where considerable investments have been made in a new, efficient production system. Fagerhult will also use its factory in China and outsourcing elsewhere to continue its international expansion.

"This is of course a very difficult decision to take, but in order to secure the company's future competitiveness, we have to become more efficient", commented Per Borgvall, CEO and President of Fagerhult.

"I have a complete understanding that the employees feel worried about this situation, but we have decided to inform about the negotiations with the trade unions straight away, in order to avoid rumours and speculations."

"We will of course do our outmost to help everyone who is affected by the closure. This will be done in close consultation with both the representatives from the trade unions and the local authorities in Örnsköldsvik."

By closing down the unit in Örnsköldsvik, Fagerhult expects to get an annual profit improvement of about SEK 15 million from 2008. The costs connected with the closure are expected to be about SEK 20 million, and will affect the result of the fourth quarter 2006.
