Sectra enters the public healthcare market in Belgium

The Henri Serruys Ziekenhuis AV, a Belgian hospital located in Oostende, has invested in medical-imaging systems from the IT and medical-technology company Sectra. This is the first public hospital in Belgium to order Sectra's radiology IT solution.

The investment comprises Sectra's digital solution for managing and archiving radiology images (PACS) for the hospital's radiology department.
