Developing a broadband platform for Utfors

Utfors has intensified its collaboration with Cell Network in the development of a broadband platform for consumer and corporate services. The assignment is worth MSEK 25.

Cell Network has been entrusted with the task of working with Utfors to develop a concept version of their platform for broadband services. This project will bring together strategic expertise from both companies.

Utfors, which supplies both data traffic and fixed and mobile telephony, is now ready for the next phase: broadband services for media consumption aimed at the consumer and corporate market.
