

Aspiro chosen as preferred provider for TV3 Latvia

Aspiro Mobile Solutions has signed an agreement with TV3 Latvia to become their preferred provider of gateway services, editorial and commercial user services. The first joint project will be a new interactive TV show that premieres late 2008. Aspiro Mobile Solutions is part of the stock listed Aspiro group, which is the Scandinavian market leader within mobile services.

The cooperation with TV3 Latvia, who is a part of the MTG group, is within Aspiro's new Mobile Solutions business area (previously Business Solutions).
