

## Filing to the stock exchange 1. Kongsberg Automotive ASA

### Exercise of employee share options in Kongsberg Automotive ASA ("the Company").

1. Out of a total of 10.930.184 exercisable options, employees in Kongsberg Automotive Group have exercised 2.364.482 options. Each share option corresponds to one share. The underlying shares have been provided by sale of the Company's holding of treasury shares. Subsequent to the transaction Kongsberg Automotive ASA holds 4.821.460 own shares. There will be no share capital increase due to the exercise of share options.
