**VIASAT TO DISTRIBUTE TV 2'S PREMIER LEAGUE CHANNELS ON ITS
NORWEGIAN DTH SATELLITE PAY-TV PLATFORM**

Modern Times Group MTG AB (publ.) ('MTG' or 'the Group'), the international entertainment broadcasting group, today announced that Viasat Broadcasting has signed an agreement with Norwegian broadcasting group TV 2 AS to distribute TV 2's three Premier League channels – TV 2 Premier League HD, TV 2 Premier League HD 2 and TV 2 Premier League HD 3 – on its Norwegian DTH satellite pay-TV platform.

The agreement is the first of its kind in Norway following TV 2's acquisition of the Barclays Premier League rights for Norway in March. TV 2's three Premier League HD channels will be available for Viasat's subscribers from the start of the 2010/11 season in August. MTG already holds the exclusive rights to the English Barclays Premier League in Sweden and Bulgaria.

Viasat's subscribers will now have access to all Barclays Premier League matches until the end of the 2012/13 season. Viasat already has an extensive portfolio of football rights in Norway, which includes the FIFA World Cup 2010, UEFA Champions League, UEFA Europa League and the FA Cup. The rights to the FIFA World Cup are shared between Viasat and TV 2, and the matches will be broadcast on Viasat Sport HD and TV 2 HD. Viasat's portfolio of dedicated sports channels in Norway also comprises Viasat Sport, Viasat Motor, Viasat Fotball, and Viasat Golf.

Hans-Holger Albrecht, President & CEO of MTG, commented: "The agreement with TV 2 strengthens our leading position as a premium pay-TV provider in the Nordic region. It is the next step in the ongoing changes to the Scandinavian broadcasting landscape, and we are proud to be able to provide our Norwegian subscribers with access to the biggest and best sports rights. Barclays Premier League is one of the strongest and most popular sports rights on the market and is highly appreciated by sports fans."
