## **VIASAT EXTENDS RIGHTS TO UEFA CHAMPIONS LEAGUE COVERAGE**

**Modern Times Group MTG AB, the international entertainment-broadcasting group, today announced that it has prolonged its exclusive live broadcasting rights to the UEFA Champions League, for Sweden, Norway and Denmark, until the end of the 2008 / 2009 championship in the Spring of 2009. Viasat already held the exclusive rights to the Championship until the end of the 2005 / 2006 season.**
