## Saab signs cooperation agreement with NonLethal Technologies Inc.

Defence and security company Saab Bofors Dynamics Switzerland Ltd (SBDS) and US-based NonLethal Technologies Inc. (NLT) have today signed a long-term cooperation agreement whereby SBDS will market and sell the IronFist<sup>TM</sup> and Cobra40<sup>TM</sup> less-lethal weapon systems, including their 38-mm and 40-mm munitions, on an exclusive basis in the European market.

SBDS is a fully-owned company of Saab, located in Thun, Switzerland and organized within Saab's Business area Dynamics. The company is a leader in the design, development and production of mortar rounds, warheads and less-lethal applications. It is a specialist in total munitions life cycle management and provides servicing of different ammunition types, chiefly for large-calibre products.
