## Simonazzi acquisition completed

Tetra Laval and the SIG Group have now completed the transaction for Tetra Laval to acquire SIG Simonazzi. As of today Tetra Laval has formally taken ownership of Simonazzi and will now start the integration of their activities with Sidel.

Present in 20 countries, Simonazzi designs, produces and sells filling and labelling equipment in addition to complete bottling lines for packaging liquid foods in plastic and glass bottles as well as beverage cans. Simonazzi posted sales in 2004 of € 320 million and has 1,500 employees.
