The SWATS Display-Card is an ISO7816 compatible card with a integrated LCD display and browse buttons. The integrated display enables the cardholder to, off-line, read information stored on the card. The information is automatically updated whenever the card is processed in a card reader. The operating system is fully compatible with any host system operating SmartCards, and can therefore easily be integrated in any existing applications. The card is fit with a lithium battery giving the card a life span of 2 years.
