Intentia Consulting France, in cooperation with Messier Services France, will define and develop all processes (commercial, production and financial) throughout the rest of this year. Operational start-up is scheduled for mid-2002. The software will be installed at Messier Services France initially and then be gradually deployed throughout the network, including Messier Services America (Washington, D.C.), Messier Services U.K. (Gloucester) and Messier Services Asia (Singapore).

Movex Aviation features a real-time management approach covering all aspects of MRO, while Intentia's industry expertise offers the supporting consulting services.
