## Asset Transfer Unit working with Anthony Collins Solicitors to improve the asset transfer process

The guidance is intended to help community organisations and local authorities understand their roles and responsibilities in the process. Anthony Collins are also to explore the potential for model legal documents to support transfer activity, and intend to consult extensively across local authorities in England to establish what is needed by public sector legal practitioners.

## **Notes to editors:**

- 1.
