According to tradition, the Swedish Academy will set the date for its announcement of the Nobel Prize in Literature later.

Each 2010 Nobel Prize will amount to 10 million Swedish kronor (2009: 10 million Swedish kronor). The sum of the Nobel Prizes (Physics, Chemistry, Physiology or Medicine, Literature and Peace) is 50 million Swedish kronor. In addition, the Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel will amount to 10 million Swedish kronor.

Staff changes at the Nobel Foundation

In conjunction with its meeting today, the Board is also announcing that after 21 years at the Nobel Foundation, Åke Altéus is retiring on July 31, 2010. Mr Altéus has been Deputy Executive Director of the Nobel Foundation, in charge of finance and accounting.

Mr Altéus's areas of responsibility will be divided between two people. John Vivstam will take over as Chief Investment Officer. Mr Vivstam's most recent position was at Posten's Pension Fund, and he was previously employed at Carnegie Investment Bank. Barbro Jonsson will take over as Head of Administration. Ms Jonsson has been employed as the Nobel Foundation's Accountant since 1997.
