### Atlas Copco acquires Austrian mobile crushing and screening company

**Stockholm, Sweden, August 31, 2010:** Today, Atlas Copco Austria GmbH has acquired Hartl Anlagenbau GmbH, Austria, a company that manufactures and sells mobile crushers and screeners.

By this acquisition Atlas Copco will enter the growing mobile crushing and screening market, thereby strengthening the Group's offering in the areas of quarrying and recycling.

Hartl Anlagenbau GmbH is a privately owned company based in St. Valentin, Austria and currently employs approximately 110 people. In 2009 the company's total revenues were MEUR 21 (MSEK 197). The products are mainly distributed through a dealer network and partners. Hartl will become a product company within the Atlas Copco Surface Drilling Equipment division. The parties have agreed not to disclose the purchase price.
