## New Managing Director at CityMail Group

The Board of Directors of the O-listed CityMail Group has appointed Fredrik Olsson as the new Managing Director. Fredrik Olsson was most recently a partner and Head of the Digital Markets and Supply Chain service area within Andersen's consulting business. It is proposed that CityMail's current Managing Director, Bror Anders Månsson, be appointed as the new Chairman of the Board of Directors. The Deputy Managing Director, Håkan Ohlsson, will serve as acting Managing Director until Fredrik Olsson takes office. Malcolm Hamilton and Nils Ridhammar remain as members of the company's executive management.

- During ten years, CityMail has pushed through the deregulation of the Swedish postal market as the first private mail distribution company in the world. Bror Anders Månsson has been a very important driving force behind this. The company is now entering a new phase with an established international strategy and the Swedish distribution operations have been sold the British postal authority, Consignia. Thus, the time is right for the appointment of a new Managing Director. With Fredrik Olsson's expertise and professional background, we will strengthen the management of CityMail Group and thereby be able take a further step in our development and international expansion, says Jan Freese, Chairman of the Board of Directors of CityMail Group.
- CityMail has created a very interesting and unique position for itself on the international market for customer communications. This, together with the high growth potential of this partially new market, is the main reason why I have very enthusiastically accepted this exciting work, despite that I have to leave a very professional, expansive company that enables its employees to develop, says Fredrik Olsson.
- During the past year, we have carried out a structural reorganisation in the Swedish distribution operations, entered into strategic alliances, and adopted a new international strategy for CityMail Group. It is with satisfaction that I can look back at the restructuring we have carried out and I view CityMail Group's future with optimism. Fredrik Olsson has an extraordinarily suitable background for the strategy we have adopted and it is with the greatest confidence that we can hand over operational responsibility for the company to him, says Bror Anders Månsson.
