## Lisa Richards-Everton Civil Claim Media Briefing Notes

### Background

The civil claim for Lisa Richards-Everton against The Heart of England NHS Foundation Trust will take place on Thursday 11<sup>th</sup> November, 2010 at the Birmingham Civil Justice Centre, following the death of husband, Paul Richards, who died as a result of receiving a fatal overdose of the drug Amphotericin at Heartlands Birmingham Hospital in July 2007.

Lisa Richards-Everton and their three children have understandably all been greatly affected by the premature loss of a loving husband and father.

Paul Richards, 35 from Sutton Coldfield had been diagnosed with non Hodgkins' lymphoma in April 2007 and had been receiving chemotherapy at the Birmingham Heartlands Hospital. On 10<sup>th</sup> July 2007, Mr Richards had been suffering from the side effects of the chemotherapy. On 20<sup>th</sup> July 2007, he was prescribed an anti-fungal drug, Amphotericin. This drug was administered at five times the appropriate dose causing irreparable damage resulting in the death of Paul Richards.

On the evening the drug was administered, Mr Richard's wife, Lisa Richards-Everton, had been called to the hospital having been told that his condition had deteriorated. Lisa was accompanied by the couple's eldest child who was 15 at the time. On arrival at the hospital, Lisa was visibly shocked by the changes in her husband. In the hours that followed, Lisa was to witness horrifying and shocking events that have left her traumatised beyond the normal grief reaction. Her son has also been severely affected by the events he witnessed and the emotional state his mother was in.

At the inquest into the death of Paul Richards which was held on 2<sup>nd</sup> February 2009, a verdict of Accidental Death contributed to by neglect was reached. The Heart of England NHS Trust admitted a breach of duty of care owed to Paul Richards in administering the fatal overdose of Amphotericin.

The civil hearing on 11<sup>th</sup> November is to settle the amount of compensation for Lisa Richards-Everton and the couple's three children.

Lisa Richards-Everton continues her campaign for tighter restrictions on the administration of drugs in the NHS and works closely with campaign groups and Action Against Medical Accidents (AvMA).

### Key Issues

1. The Heart of England NHS Foundation Trust failed to take appropriate steps to safeguard the lives of those in its care by failing to ensure that there was a safety system in place to ensure that Amphotericin was prescribed and administered properly
2. A failure by medical staff to seek alternative advice/clarification on the drug type and usage
3. Lack of training which led to a failure to access the correct information from the Electronic British National Formulary which is the national drug dosage manual

4. Failure of prescription/observation charts to provide all the relevant information
5. The failure of the Heart of England NHS Foundation Trust to provide protocols/statements for the practice of the administration and control of drugs

### Quotes/Comment

Tony Hall, Partner, Anthony Collins Solicitors:

“We are pleased to resolve this claim on behalf of Lisa Richards-Everton and her family, but stress that no amount of compensation would make up for their premature loss.

“There is a need to ensure that there is appropriate implementation of recommendations from national patient safety alerts and appropriate monitoring of procedures that are performed in hospital.”

Lisa Richards-Everton:

“No amount of compensation will make up for the loss of Paul.

“There seems to be no concern for patient safety Paul’s death could have been so easily avoided. I am appalled that three years on there are still poor systems in place, which do not safeguard patients. Amphotericin is now only available through pharmacy at Heart of England Trust, but it is my understanding that it is still readily available on wards in hospitals throughout the UK.

“I will continue to work with Action Against Medical Accidents (AvMA) to ensure safer systems are put in place to safeguard patients. Patient safety should be priority, but sadly I know this is not the case.”

### Amphotericin

Amphotericin – a drug to fight fungal infections – is sold under different brand names and comes with different dosages. Two brands were confused and prescribed to Paul at five times the recommended dose.
