## TietoEnator develops mobile payment solution for Europolitan Vodafone

TietoEnator-owned Entra has been assigned by Europolitan Vodafone to develop a platform for payments for services via mobile terminals. The solution will be introduced by Europolitan Vodafone during the first half of 2002. The contract supports TietoEnator's strategy of promoting mobile payment solutions in the global market.
