Genesys Conferencing sets new milestone in strategic partnerships with PC manufacturers

Genesys Meeting Center will start to be incorporated into two thirds of the manufacturer's PCs sold in France as from this month followed by Italy and Spain. The partnership also includes a free trial of Genesys Meeting Center for PC users. Genesys Conferencing's partner sells several million PCs annually in Europe and is recognized as a market leader in the PC industry world-wide.

"This is an exciting partnership for two companies that are leaders in their respective fields," explained Emmett Hossack, Vice President, Strategic Partnerships for Genesys Conferencing. He added: "We are giving our partner a significant competitive edge by integrating Genesys Meeting Center into a leading global PC product, while driving demand for web conferencing, which is already acknowledged to be changing the way that people communicate and work together."
