German ADSL operator orders set-top box system from Kreatel

LINKÖPING, SWEDEN, June 4, 2002 – German broadband operator HanseNet has ordered the Kreatel IP-based set-top box system to be used for TV services in ADSL and fiber (FTTH) networks. In May 2002, HanseNet had nearly 20 000 DSL-subscribers connected in Hamburg.
