GlaxoSmithKline plc [GSK] announced today that Tim Tyson, currently President, Global Manufacturing & Supply, will leave GSK to take up a new position as President and Chief Operating Officer for ICN Pharmaceuticals Inc., a research-based specialty pharmaceuticals company, based in Costa Mesa, California. This becomes effective 1 December 2002.

Dr. David Pulman, currently Senior Vice President - Strategy, Logistics & North American Supply, Global Manufacturing & Supply, GlaxoSmithKline, will be named President, Global Manufacturing & Supply, and will report to Robert Ingram, until Mr. Ingram's retirement on 31 December 2002. Subsequently he will report to David Stout, who assumes the role of President, Pharmaceuticals Operations, from January 2003. Dr. Pulman will be based in Research Triangle Park, North Carolina, US.
