## **CSC SIGNS \$450 MILLION OUTSOURCING AGREEMENT WITH ISS IN EUROPE**

Helsinki, June 5, 2003 – Computer Sciences Corporation (NYSE: CSC), one of the world's leading information technology (IT) services firms, today announced it has signed a 10-year IT outsourcing agreement with ISS A/S, a global leader in facility services. The contract is valued at \$450 million.

Under the terms of the agreement, CSC will assume responsibility for the full range of IT services at more than 800 ISS sites throughout Europe. This includes the delivery and management of mainframe, midrange, desktop, help desk, network, and application development and support services.

Upon compliance with local legislative and consultative requirements, approximately 120 ISS employees will transfer to CSC in Europe starting June 1, 2003.

“While this agreement has both short-term and long-term benefits for ISS, the long-term benefits have clearly been the most important factors in this decision,” said ISS Group Chief Executive Officer Eric Rylberg. “For a global company like ISS, it is crucial that we develop and provide uniform service concepts to our customers across country borders and, in terms of administration, provide the exact service that our customers demand.”

“CSC’s experience in working with large, geographically disbursed companies, and our track record of delivering operational and financial results to those companies, make us an ideal fit to support ISS,” said CSC President and Chief Operating Officer Mike Laphen. “We are pleased by the confidence ISS has placed in us, and we look forward to helping the company achieve its business goals.”
