## Sectra launches web deployable PACS

Sectra PACS<sup>TM</sup> release 10 is the latest version of the award-winning Sectra PACS<sup>TM</sup> product. Based on an entirely new web deployment strategy, the system meets all the requirements needed for a full-scale, high performance web deployable PACS.

Sectra PACS<sup>TM</sup> release 10 includes such features as zero client administration for automatic workstation upgrades without user intervention, and a roaming desktop that provides users with a personalized desktop environment and a consistent set of tools regardless of where the users logs on. Further, system administration and upgrades can be performed with minimal effort," he continues.

Sectra will showcase Sectra PACS release 10 at the Radiological Society of North America (RSNA), the largest radiology exhibition in the world in November in Chicago. Overall, the theme for RSNA 2003 will be demonstrating how Sectra PACS can be used as a basis for imaging solutions that meet the challenges of radiologists as well as their clinical colleagues throughout the enterprise.
