As at **30 November 2003**, ASCoT held **110** investments, the largest of which represented **3.1%** of investable assets. The market value of investments was **£418.2m** and total Shareholders’ Funds were **£433.4m**. ASCoT invests only in small UK quoted companies and does not invest in any unquoted securities, AIM listed securities or securities issued by investment trusts or investment companies. ASCoT has bank debt facilities available to allow gearing of up to **18.5%** of Shareholders’ Funds of which **0.0%** is currently utilised.

The number of Ordinary Shares of 1p currently in issue is **98,809,788**. Following the final exercise of Warrants on 31 March 2003, there are no longer any Warrants in issue.

Dividends are paid, semi-annually, to Ordinary Shareholders with the interim announced each July and paid in September and the final announced each January and paid in March.
