Mats Lundqvist appointed to manage Song Networks

Mats Lundqvist, currently acting Managing Director of Song Networks Holding AB (publ) (Song), will be appointed with immediate effect to the position of permanent Managing Director to manage Song, with TDC A/S as the new owner.

Mats Lundqvist was born in 1967 and has a business degree from the Stockholm School of Economics. He began his career with eight years with McKinsey & Company in Scandinavia. Mats was then appointed Managing Director of Arrowhead, a data operator owned by Vattenfall, which was acquired by Song. During his time with the Song Group, the company has gone from a negative EBITDA result of SEK -33 million during the second quarter of 2002 to a positive EBITDA result of SEK 82 million during the third quarter of 2004.
