The survey also noted that Axis has 50 percent brand awareness, making the company the most widely recognized and dominating brand name in the PC-independent network camera market.

"Axis has quickly become a dominating force in the fast growing network camera market," said Chris Cherrington, Frost & Sullivan consultant analyst. "The company has taken its initial lead in Web attraction and has successfully emerged as a leader in the increasingly important security and surveillance market for network cameras."
