CellPoint To Seek Parallel Listing in Stockholm

Stockholm, October 10 – Peter Henricssion, Chairman and CEO of CellPoint Inc. (Nasdaq: CLPT; www.cellpt.com) announces that CellPoint will apply for a parallel listing on the O-List of the OM Stockholm Exchange. "We announced our intention to seek a parallel listing in Europe because our primary commercial market for location and telemetry services is Europe," said Henricsson. "Our board's decision was to apply for a parallel listing in Sweden and we have already initiated discussions with the OM Group in Sweden, which runs the OM Stockholm Exchange, to effectuate a listing on the O-List as soon as possible."

CellPoint evaluated several different alternatives and the decision to list in Stockholm was based on the fact that the Company has the majority of its people and development in Sweden. Stockholm is also known as a worldwide center for mobile technology; CellPoint's office in Kista is in the heart of what is known as the 'Wireless Valley'. "We will maintain our Nasdaq listing in the United States and will soon be able to offer European shareholders improved access to trading in CellPoint's stock," added Henricsson.

Recent Events

CellPoint has recently announced several commercial contracts for its technology and services. "We have also expanded our location technology and services offerings with market-driven product developments," continued Henricsson. "We feel it is clear that our leadership in location technology and services is becoming even more pronounced as we continue to announce commercial deployments in our target markets.

Swedish subsidiary Unwire has also announced more than \$20 million in contracts in Europe and Asia over the last two months.

Unwire's GSM terminals are also integrated with CellPoint's Mobile Location Services platform. Several commercial applications are available for business and personal location services including Resource Manager™ for mobile resource management, iMate™ for location-sensitive information and Finder™, an application for locating friends and family.

Common estimates for GSM subscribers to 2005 exceed 1.5 billion users, whereas worldwide shipments of cellular handsets with embedded GPS (Global Positioning System) are estimated at four million in 2000 and 38.5 million in 2003. The wireless location services industry in Europe alone is estimated to generate more than \$80 billion between now and 2005 (The Strategis Group).
