The city of Almaty also has a lot of unique architectural sites. Among those are the bath-house Arasan and the Cathedral in the Park of 28 Panfilov Soldiers. Other attractions include the Central Stadium, the Presidential Palace and Republic Square, the Central Museum, the Hippodrome and the Medeu Ice Skating Stadium.
