EQT VI acquires data and telecom provider Ventelo

- EQT VI acquires Norway's second largest data and telecom provider Ventelo
- EQT VI's strategy is to significantly strengthen the fiber network offering to Norwegian companies and organizations by creating a strong challenger in the Norwegian data and telecom market
- EQT VI to provide expertise, resources and support for further profitable growth and fiber network expansion

EQT VI has agreed to acquire Ventelo Holding AS ("Ventelo") from BKK, Troms Kraft, Agder Energi, NTE, Eidsiva Bredbånd and Altibox for an equity value of up to NOK 1,800 million. Ventelo is Norway's second largest provider of data and telecom solutions, in addition to controlling one of only two nationwide fiber networks in Norway, with metro ring networks in the largest cities. Ventelo expects revenues in 2011 of NOK 2,600 million and an EBITDA of approximately NOK 400 million.

"By acquiring Ventelo, EQT VI is taking another step towards improving the high speed fiber network offering by building a strong challenger in the Norwegian data and telecom market. Currently, Norwegian companies and organizations are served with lower data speed and capacity than most people have in their homes. Going forward, the data traffic in Norway will continue to grow rapidly and EQT VI is committed to invest in developing Ventelo's already strong offering", says Anders Misund, Partner and Head of EQT Partners Norway, investment advisor to EQT VI.

"With a strong number two position and reinforced with the expertise and resources of EQT VI, Ventelo is well positioned to enhance the growth potential in the Norwegian data and telecom market. Short term, EQT VI will support the management team in providing Norway's leading data and telecom solutions to its customers, in addition to initiate the process for creating a stronger platform for future growth and development", says Gunnar Asp, who will take the role as Chairman of the new Ventelo Board of Directors.

Gunnar Asp is Industrial Advisor to EQT VI and Chairman of, among others, EQT V-owned InFiber (former Hafslund Fibernett), acquired in January 2011. InFiber is the owner and operator of Norway's largest operator neutral optical fiber network, located in the Greater Oslo area.

"We are proud to get EQT VI as owner. EQT is the leading North-European private equity group with a well-respected industrial mindset. EQT has vast experience from successful investments in the data and telecom industry, in addition to several significant investments in Norway. I'm looking forward to working with our new Board of Directors and owners in
