The framework agreement runs over a period of three years with potential for extension. An initial order has been received for the new, environmentally friendly, Safetykleen Bio™ cleaning system with an estimated value of EUR 8.6 million over three years. Revenue is expected from the second quarter of 2012. The order is handled by PartnerTech's Customer Center in the UK and production will cover development services from the unit in Moss, Norway as well as deliveries of complete systems from the unit in Myslowice, Poland. The framework agreement will potentially cover further orders including the full scale of PartnerTech's competences within electronics, mechanics, enclosures and system integration.

The Safetykleen Bio™ cleaning system is an innovative concept where biologically degradable material is used instead of traditional detergents.

It also demonstrates the advantage of our global structure where the local Customer Center can provide service close to the customer in combination with cost efficient production.
